Public Liability insurance will cover the company in the event of accidental injury to clients by our business operation, in addition to damage to third party property while on business.

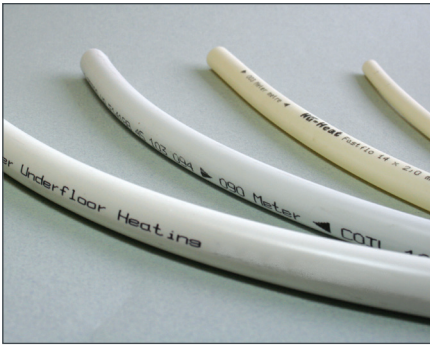
- **Products Liability to the value of £50 million.**

Fastflo® heating pipe has a 50-year warranty. It is guaranteed for 10 years (third-party insurance-backed) for full reinstatement and for a further 40 years for material replacement only.

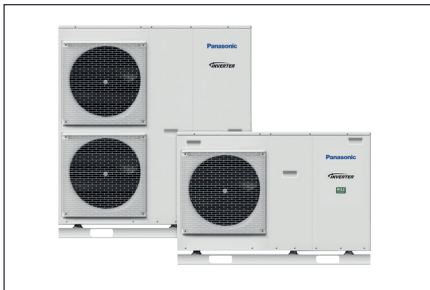

### NIBE AIR SOURCE & GROUND SOURCE HEAT PUMPS

- All NIBE heat pumps purchased through Nu-Heat carry a 7-year warranty.
- Heat pumps must be commissioned and signed-off by Nu-Heat, serviced every year and the servicing / Benchmark documentation must be completed.
- The installer / homeowner must register the warranty through Nu-Heat within 28 days of installation.
- The warranty is only valid for appliances purchased and used in mainland Great Britain.
- Quality Standards Registered; ISO 9001:2000 – Quality; ISO 14001:2004 – Environmental Management.
- NIBE Heat Pump Certificates of Conformity (for EC directives) are available for F2040, 1145, 1245 and 1345.



### PANASONIC AIR SOURCE HEAT PUMPS

- All Panasonic heat pumps purchased through Nu-Heat carry a 5-year warranty.
- Heat pumps must be commissioned and signed-off by Nu-Heat, serviced every year and the servicing / Benchmark documentation must be completed.
- The installer / homeowner must register the warranty through Nu-Heat within 28 days of installation.
- Quality Standards Registered; ISO 9001:2000 – Quality; ISO 14001:2004 – Environmental Management.
- Panasonic Heat Pump Certificates of Conformity (for EC directives) are available for all supplied units



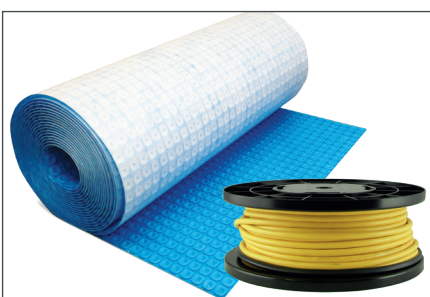
### EnergyPro SOLAR THERMAL COLLECTOR

- Nu-Heat EnergyPro Solar Thermal Collectors have a 10-year parts warranty.
- The solar control station carries a 2-year parts warranty.

### CYLINDERS

- Megacoil cylinders have a 25-year warranty.
- EnergyPro cylinders carry a 25-year warranty.
- EnergyPro Super-Duplex cylinders for use with private water supplies have a 10-year warranty (conditions apply).

All cylinders should be installed in accordance with the instructions in the *Installation Manual* and require a full service history.



### ELECTROMAT® ELECTRIC UNDERFLOOR HEATING

- Nu-Heat ElectroMat® heating cable and de-coupling membrane is covered by a lifetime warranty (conditions apply).
- The EneoStat has a 2-year warranty.
- The *Commissioning Form* in the *Installation Manual* must be completed in order to validate the warranty.
